Rules for canoeing (Mattsee)

- A maximum of 3 or 4 persons per canoe. The number of seats is marked with yellow Zellhof Stickers.
- One paddle per person
- Life jackets are compulsory
- Canoes will only be given out to adult leaders over 18 years old
- The responsible leader must understand and accept the conditions of canoe and boat hire and confirm this with their signature.
- The canoes are put in and out of the water using the wooden slide
- Get in and out of the canoe using the pier
- Keep the canoe at least 5m away from the water lilies and the reed beds.
- Do not land the canoes at other landing sites on the lake
- Pay attention to the storm warning light! The storm warning light is on the roof of the public beach complex in Mattsee
- In case of a storm warning or in bad weather, go back immediately to the landing stage
- The use of canoes is at your own risk. Pfadfinderdorf Zellhof does not accept any responsibility for any accidents

Rules for boating (Grabensee)

- Lake Grabensee is a nature reserve. Pfadfinderdorf Zellhof has received a special exemption from the nature reserve regulations to allow boats to be taken onto the Grabensee under strict conditions.
- According to nature reserve regulations nonZellhof boats are not allowed at Grabensee.
- Boats must only be used on the lake near the pier and in the middle of the lake. The boat must keep at least 200m away from the reeds and the banks of the lake (see map).
- A maximum of 5 boats are allowed on the lake simultaneously at any time.
- Rowing the boat directly towards water birds is not allowed.
- Boating is only allowed in the months of June, July and August between 8.00 and 18.00.
- Do not leave Lake Grabensee and don't land the boat at other places around the lake.
- The deposit is EUR 10 per boat.
- A maximum of 4 people are allowed in each boat, with only one person rowing.
- The oars are only given out to leaders 18 years and older.
- The responsible leader must understand and accept the conditions of canoe and boat hire and confirms this with his/her signature.
- Carry the boat in and out of the water.
- Give the oars back only to the Zellhof team.
- In case of a storm warning, go back immediately to the pier. The storm warning light is at the public beach complex in Perwang.
- The use of boats is at your own risk. Pfadfinderdorf Zellhof does accept any responsibility for any accidents.

Conditions for canoe and boat hire

- The deposit of EUR 10,- per boat or canoe might be used to cover minor damage to boats or canoes. The hirer is also liable for any damages that are not covered by the deposit.
- If the hirer does not use the canoes or boats appropriately, or not in accordance with the canoe or boat rules, the hirer will be held responsible and the hired items must be returned immediately on request.
- Any damage to the canoes or boats noticed before use must be reported to the team immediately.
- The hirer must report any damage that occurs during the use of the canoes or boats to the team.
- The hirer is responsible for any damage caused either by the hirer himself or any third person, whom the hirer hands over the canoes or boats to.
- If the canoe tour is conducted by a qualified canoe instructor. Such instructor may act as hirer provided that this is agreed in writing before the beginning of the canoe tour.
- The hirer and/or any third person shall be liable for all damages, injuries or infringements of the nature protection laws and regulations caused by them. In such a case the hirer or such third person shall hold Pfadfinderdorf Zellhof harmless. Pfadfinderdorf Zellhof shall not be held liable for such damages, injuries or infringements.

Rules for lake swimming

- Each group must post one of its members as a lifeguard.
- The lifeguard should stand clearly visible on the pier, watching over the swimmers.
- The lifeguard should be a good swimmer, at least 18 years old.
- The lifeguard should make him or herself aware of the lifesaving equipment (the float and life ring).
- The lifesaving equipment should only be used in an emergency.
- The entrance to the pier should be kept free at all times.
- Sunbathing only on the grass, not on the pier!
- Don't push anyone into the water.
- Jumping into the water is only allowed from the end of the pier.
- Swimming and water activities are only allowed between 7.00 and 20.00 hours.
- Only get in and out of the lake at the Zellhof swimming area.
- Keep at least 5m away from the reeds and the water lilies.
- Don't break off any reeds or water lilies.
- Don't take any bottles or glasses into the swimming area or the surrounding grassy slope.
- Swimming is forbidden if there is a storm warning.
